- Re-activated 157 aircrafts at end-1Q23, which represents only 70.0% of the fleet in 2019 and is on track fully operates their aircrafts in 3Q23.
- Future growth will be driven by plans to operate 290 routes (25 routes more than 2019) that is in line with the strong revival in tourism activities across the globe.
- Technically, traders may anticipate for a potential consolidation breakout above RM0.81 to target the next resistances at RM0.855-0.88 with long term target set at RM1.00.





Trading Catalyst

- Capital A Bhd (CAPITALA) has transformed from one of the leading ASEAN airline service providers into a digital travel and lifestyle platform that leverages on data and technology. At end-1QFY23, CAPITAL recorded 1.4m BigPay users, 12.9m Airasia SuperApp monthly users and 5.7m teleport deliveries.
- CAPITALA has re-activated 157 aircrafts at end-1Q23, which represents only 70.0% of the fleet in 2019 and is on track fully operates their aircrafts in 3Q23. Meanwhile, we gather that load factor has improved to 89.0% during the quarter vs. 75.0% recorded in 1Q22, driven by all round improvement across Malaysia, Thailand, Indonesia and Philippines operations.
- We gather financial position in 1Q23 has turned more stable, driven by stronger contribution from the aviation segment, coupled with the lower fuel prices. With plans to operate 290 routes (25 routes more than 2019), we reckon that further growth is largely on the cards, driven by the strong revival in tourism activities across the globe.

Technical Outlook

Technically, price has recovered since end-November 2022. After climbing above SMA200 in early January 2023, price has formed an uptrend formation, with the higher high and higher low formation in shape. After close to 3 months of consolidation, traders may anticipate for a potential breakout above RM0.81 to target the next resistances at RM0.855-0.88 with long term target set at RM1.00. Support is pegged at RM0.75 and cut loss is located at RM0.745.
